INSTALLATION



Use this product in accordance with appropriate electrical codes and regulations.

- 1. Install device in standard electrical box measuring at least $3" \times 2" \times 2''_{2}"$ (76 x 51 x 63.5mm)
- 2. Wire device in accordance with NEC requirements
- 3. Connect wires following Wiring Diagram shown in Diagram A
- 4. Mount device in electrical box using screws provided
- 5. Install wall plate

NOTE: Back wire and side wire terminals accept #12 to #14 gauge copper or copper clad wire


SIDE WIRE: Loop wire around terminal screws and firmly tighten terminal screw

BACK WIRE: Insert wires through terminal holes in back of device. Tighten terminal screws firmly

6. Once installation is complete, restore power at circuit breaker or fuse.
